I, Abhay Kumar, Company Secretary in Practice, has been appointed *vide* Letter dated July 24, 2026 by Vivo Collaboration Solutions Limited (hereinafter referred to as '**Company**'), having CIN L72900DL2012PLC230709 and having registered office at 315, Third Floor, HB Twin Tower Netaji Subhash Place, Pitampura, Delhi-110034 to issue this Compliance Certificate in accordance with Regulation 163(2) of Chapter V of SEBI (Issue of Capital and Disclosure Requirements) Regulations 2018 as amended from time to time, (hereinafter referred to as "**Regulations**").

In accordance with the Regulations, the Company has proposed issue of 22,00,000 Warrants convertible into Equity Shares at an issue price of Rs. 77/- (Rupees Seventy Seven) each, on a preferential basis ("**Proposed Preferential Issue**"). The proposed preferential offer is for consideration in cash. The Proposed Preferential issue was approved at the meeting of Board of Directors of the Company held on July 24, 2026.

On the basis of relevant management inquiries, necessary representations and information received from/furnished by the management of the Company ("**Management**"), as required under the aforesaid Regulations, we have verified that issue is being made in accordance with the requirements of these Regulations, we have verified that the issue is being made in accordance with the requirements of these Regulations as applicable to the preferential issue. More specifically, I have performed the following procedure to confirm the compliance with required conditions:

- (i) Reviewed the Memorandum of Association and Articles of Association of the Company;
- (ii) Reviewed the present capital structure including the details of the authorized, subscribed, issued, paid up share capital of the Company along with the shareholding pattern;
- (iii) Reviewed the resolutions passed at the meeting of Board of Directors;
- (iv) Reviewed the list of proposed allottees;
- (v) Noted that the relevant date in accordance with Regulation 161 of the Regulations for the purpose of minimum issue price is 22nd July, 2026;
- (vi) Reviewed the statutory registers of the Company and list of shareholders issued by RTA;
- (vii) Reviewed the disclosures under the SEBI (Prohibition of Insider Trading) Regulations, 2015 & SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, if any, made by proposed allottees, promoter or promoter group during the 90 trading days preceding the relevant date;
- (viii) Reviewed the details of buying, selling and dealing in equity shares of the Company by the proposed allottees, promoter or promoter group during the 90 trading days preceding the relevant date;
- (ix) Verified that the Company has obtained the Permanent Account Numbers of the proposed allottees;



- (x) Reviewed the notice of Annual General Meeting for seeking approval of shareholders, explanatory Statement;
- (xi) Computation of the minimum price of the shares to be allotted in preferential issue in accordance with the Regulations. The minimum issue price for the proposed preferential issue of the Company, based on the pricing formula prescribed under these Regulations has been worked out at Rs. 56.96 per equity shares;
- (xii) With respect to the compliance with minimum price for proposed preferential issue in accordance with Regulation 164(1) of SEBI ICDR Regulations, I have issued my certificate dated July 28, 2026;
- (xiii) Board/Shareholders' resolution and statutory registers to verify that promoter(s) or the promoter's group has not failed to exercise any warrants of the Company which were previously subscribed by them;

It is the responsibility of the Management to comply with the requirements of the Regulations, including the preparation and maintenance of all accounting and other relevant supporting records, implementing and maintaining internal control relevant to preparation of draft Notice Annual General and explanatory statement, determination of relevant date and minimum price of the shares and making estimates that are reasonable in circumstances.

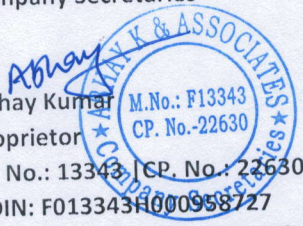
Conclusion
